Articles of amendment of the articles of incorporation of the Washington State Association of County Officials, a non-profit Washington corporation, are herein executed in duplicate by said corporation as follows:

1. The name of the corporation is the Washington State Association of County Officials.

2. The amendments to the articles of incorporation adopted by said corporation are as follows:

AMENDED ARTICLE II

This corporation shall have the public purpose of carrying out the mandate of the Washington State Legislature as expressed in RCW 36.47.010 through RCW 36.47.060 and the provisions of Chapter 130, Law of Washington, 1959 as amended, through the use of public monies contributed to the corporation by the counties of the State of Washington pursuant to said laws, to wit:

1. The coordination of county administrative programs in the best interest of the people of the State of Washington, through cooperation and education of the Assessors, Auditors, Clerks, Coroners, Sheriffs,

Treasurers, and Prosecuting Attorneys of the several counties of the state and their employees;

2. The creation and implementation of more practical and efficient county administration and procedures by disseminating such information and proposed procedural reforms through the journal of the corporation and by providing staff support for the holding of conferences, workshops and seminars for the above named officials and their employees;
3. The provision of a single source of information regarding county matters to the executive and legislative branches of the state government, to the individual counties, and to interested members of the public;
4. The providing of a biennial report or reports to the Governor, the Legislature, the counties of the state, and to all other proper persons and officials recommending procedural changes which will increase the effectiveness of the respective departments headed by the various elected county officials;
5. To propose legislation affecting counties that will inure to the benefit of the public by promoting the

efficiency and effectiveness of county government:

Provided: that promotion of legislation shall not comprise a substantial part of the activities of the corporation;

6. To do and perform any legal act necessary or permissible under said law not in conflict with the restrictions of Section 501 (C) (3) of the Internal Revenue Code of 1954 as amended.

This non-profit corporation is hereby declared to be organized in perpetuity unless sooner dissolved by the Legislature of the State of Washington, or under the provisions of RCW 36.47.

NEW ARTICLE VI

DISSOLUTION

Upon the dissolution of the corporation, the Board of trustees shall, after making provision for the payment of all of the liabilities of the corporation, dispose of the remaining corporation assets by distributing them to the counties of the state to be used for public purposes in shares proportionate to the contributions of each county to the total contributions of all the counties during the final three years of the existence of the corporation. In the event any asset may not be disposed of in the foregoing manner, such


assets shall be disposed of by order of the Superior Court of the State of Washington for Thurston County as said court shall determine to an organization or organizations organized and operated exclusively for educational purposes as shall qualify as an exempt organization under section 501 (C) (3) of the Internal Revenue Code of 1954 as amended, said organization having a purpose consistent with that of the corporation.

3. These amendments were adopted pursuant to RCW 24.03 .165 on March 2, 1979, at its regular meeting by resolution of the Board of Trustees, said resolution receiving the unanimous affirmative vote of those in attendance of which there was more than a quorum present.

ARTICLES OF INCORPORATION

Article I

NAME

The name of this non-profit corporation shall be the WASHINGTON STATE ASSOCIATION OF ELECTED COUNTY OFFICIALS.

Article II

PURPOSE

The purpose of this corporation shall be the coordination of county administrative programs in the best interest of the people of the State of Washington through cooperation of the Assessors, Auditors, Clerks, Coroners, Sheriffs, Superintendents of Schools, Treasurers, and Prosecuting Attorneys of the several Counties of the State; the creation of more practical and efficient county administration and procedures; preparation of necessary legislation; the provision of a single source of information and report biennially to the Governor, the Legislature and to all proper persons and officials, recommendations for procedural changes which will increase the effectiveness of the respective departments headed by such elected County officials; and to do and perform any legal act necessary or permissible under the provisions of Chapter 130, Laws of Washington, 1959, and the provisions of Chapter RCW 36.47.010 through RCW 36.47.060. This non-profit corporation is hereby declared to be organized in perpetuity unless sooner dissolved by the Legislature of the State of Washington, or under the provisions of Chapter RCW 36.47.

Article III

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be 1063 Capitol Way, Olympia, Washington, or such other locations as shall be authorized in accordance with the by-laws of the corporation.

Article IV

TRUSTEES

The trustees of this non-profit corporation shall be fifteen (15) in number and shall be the President, Vice-President, Second Vice-President, Secretary-Treasurer, eight members composed of one representative from each of the County officer groups or association officially affiliated with this corporation and three members at large, elected or appointed on the basis of county class designation. The names and addresses of the persons who are serving on the Board of Trustees of the corporation until the selection of their successors on the 3rd day of November, 1961, in accordance with the by-laws, are as follows:

The membership of this non-profit corporation shall consist of all duly elected, or appointed, qualified and acting persons holding the office of Assessor, Auditor, Clerk, Coroner, Sheriff, Superintendent of Schools,

Treasurer and Prosecuting Attorneys in and for the County of the State of Washington, who have designated the Washington State Association of Elected County Officials as their co-ordinating agency, and are contributing members.
